IT IS HEREBY AGREED BETWEEN: 2021 DV selectee Yasemin Karakoc , as client, and RAFAEL UREÑA and CURTIS MORRISON, as attorneys, that in consideration for attorney's representation of clients in a multiparticipant lawsuit to be filed against US government defendants in the District Court for the District of Columbia on or about June 6, 2021, and representation in consular processing, the attorney fees will be: one thousand five hundred dollars (\$1,500). The attorney fees are payable as \$500 as initial payment, and \$1,000 when clients enter the USA.

The attorneys will commence work when the initial payment is received.*

The clients understand that other individuals will be participating as plaintiffs in the FEDERAL MANDAMUS JOINER ACTION.

The government rarely discloses when an immigrant visa is issued due to the efforts of attorneys. If client's immigrant visa is issued prior to the filing of the action (lawsuit), and client notifies the attorneys immediately, then no attorney fees will be due.

If visa is issued AFTER the lawsuit is filed, regardless of whether an order has been issued in the lawsuit, the final payment of attorney fees become due upon entry. This includes when visas are issued immediately after the filing of the lawsuit, as well as when clients have to wait longer for visas to be issued.

The client understands that attorney fees are not tied to the cause of visa issuance. This means if clients are issued visas, but believe the issuance was not due to the lawsuit, that will not relieve clients of their obligation to pay the final payment of attorney fees.

The client hereby acknowledges attorneys do not have professional liability insurance.

The client understands that participating in a lawsuit could mean public disclosure of private facts.

The client understands that there are no guarantees as to the outcome of litigation.

Client acknowledges that any Credit Card Payment is for the defined services regardless of the case outcome, and there are no refunds, warranties, or guarantees.

*The attorney may stop work on the case at any time client does not pay monthly or scheduled payments of fees. The attorney reserves the right of requesting payment in full at any time client does not pay monthly or scheduled payments of fees in order to proceed with the case. There will be an additional fee to reactivate the case. Rafael Ureña and his staff make every effort to bill fairly and clearly for fees and expenses, and to represent client interests zealously and diligently. However, lawyers and clients occasionally disagree about the amount of a bill for legal services or fees related to costs and expenses. If a fee dispute arises in this matter, you may have the right to elect to resolve the dispute through arbitration pursuant to Part 137 of

the Rules of the Chief Administrator in the State of New York. A copy of Part 137 will be made available to you by Rafael Ureña should you request it.
